



**Description:**

ClearFox WWT modules are fully equipped biological treatment plants including pretreatment and clarifying. All compounds are preinstalled in a 20ft high-cube container, such as settling tank including sludge storage and buffer as well as fixed bed biological treatment section and lamella separator. The system runs fully automatically operated by a control unit.

In a first step the wastewater is mechanically treated: solids settle, sludge is stored and the inflow is equalized to Q20. The sludge has to be removed due to accumulation. Subsequently the pretreated wastewater is pumped into the fixed bed reactor by an airlift pump. It is equipped with aeration membranes, distributor system, blank holders and all support for positioning grid tube blocks in order to get a high performance bioreactor for waste water treatment. Included in the scope is a blower and airsplitters (pro rata). In order to reduce TSS a clarifying unit is connected after the modules. Secondary sludge from the clarifier is pumped back to the sludge storage.

The typical application is reduce carbon and nitrogen concentration from domestically or municipally nature. The design is according to DWA guidelines, the cleaning efficiency is approved in field tests, made by external waste water institutes (notified bodies). Test reports and certificates for static, performance, origin, DWA guidelines are available on request.
